RESOLUTION TIRZ #8

A RESOLUTION OF THE BOARD OF DIRECTORS OF TAX INCREMENT REINVESTMENT ZONE NUMBER EIGHT, CITY OF CELINA, SUTTON FIELDS II, APPROVING CERTAIN PROJECT EXPENDITURES; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Celina, Texas (hereinafter referred to as the “City”), pursuant to Chapter 311 of the Texas Tax Code, as amended (hereinafter referred to as the “Act”), may designate a geographic area within the City as a tax increment reinvestment zone if the area satisfies the requirements of the Act; and

WHEREAS, ON August 8, 2017, pursuant to and as required by the Act, the City has prepared a *Reinvestment Zone Number Eight, City of Celina, Preliminary Project and Financing Plan* for a tax increment reinvestment zone located within the City of Celina, Texas; and

WHEREAS, on September 12, 2017, pursuant to and as required by the Act, the governing body of the City (hereinafter referred to as the “City Council”) approved and adopted by Ordinance 2017-49, providing for the creation of *Tax Increment Reinvestment Zone Number Eight, City of Celina, Sutton Fields II*. Ordinance 2017-49 designated the contiguous geographic area within the City as a reinvestment zone; created a board of directors for the zone, directed final preparation of a Final Project and Financing Plan; established a tax increment fund for the zone; contained findings related to the creation of the zone; and provided for the date of termination of the zone.

WHEREAS, the Board of Directors of Reinvestment Zone Number Eight, City of Celina, Texas, desires to authorize through the passage of Resolution on September 14, 2021 for TIRZ # 8, for certain expenditures (1) TIRZ credit Payment from collections FY2019-2020, payment in FY 2020-2021 in the amount not to exceed \$9,367.36 and (2) TIRZ credit Payment from collections FY2020-2021, payment in FY 2021-2022 in the amount not to exceed \$34,521.42; directly related to facilitate development and encourage development within the zone; all of which the Board found were authorized expenditures under the Act; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF TAX INCREMENT REINVESTMENT ZONE NUMBER EIGHT OF THE CITY OF CELINA, TEXAS:

SECTION 1. The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

SECTION 2. the Board of Directors of Reinvestment Zone Number Eight, City of Celina, Texas, in accordance with the Act, hereby authorize certain expenditures (1) TIRZ credit Payment from collections FY2019-2020, payment in FY 2020-2021 in the amount not to exceed \$9,367.36 and (2) TIRZ credit Payment from collections FY2020-2021, payment in FY 2021-2022 in the amount not to exceed \$34,521.42; directly related to facilitate development and encourage

development within the zone.

SECTION 3. That if any section, article paragraph, sentence, clause, phrase or word in this Resolution, or the application thereto to any persons or circumstances, is held invalid or unconstitutional by a Court of competent jurisdiction, such holding shall not affect the validity of the remaining portions of this Resolution; and the Board of Directors hereby declares it would have passed such remaining portions of this Resolution despite such invalidity, which remaining portions shall remain in full force and effect.

SECTION 4. That this Resolution shall become effective from and after its date of passage in accordance with law.
