Conduct a public hearing to consider and act upon a request to amend the Concept Plan and Development Regulations of Planned Development (PD) No. 106 on approximately 253 acres, generally located 1,100 feet south of Sunset Boulevard and east and west of future Coit Road, within both the City Limits and the Extraterritorial Jurisdiction (ETJ). (Tuscany Ph. 2 – PD Rezoning)

Bella Lopez, Senior Planner, presented the staff report.

Chair Hangartner opened the public hearing.

Conduct a public hearing to consider and act upon a request to zone approximately 51 acres to a Planned Development (PD) with Single-Family Residential (SF-R), Single-Family Attached (SF-A), and Commercial, Retail, & Office (C) base zoning, generally located south of future Sunset Boulevard and 1,100 feet west of future Custer Road, within the Extraterritorial Jurisdiction (ETJ). (Matusek – PD Zoning)

(Tuscany Ph. 2 & Matusek Remainder – Zoning)

Madhuri Mohan, Planning Director, presented the staff report.

Chair Hangartner opened the public hearing.
