(Tarrant)

Background Information:

A General Election was held Tuesday, November 3, 2020, to elect a Council Member to Place 4. No candidate for Place 4 received a majority vote (50.1%) as required by the Texas Constitution for a candidate to be elected to a three year term of office. The City is contracting with Collin County and Denton County to conduct the runoff election to be held Tuesday, December 8, 2020.

ORDINANCE 2020-104

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CELINA, TEXAS, TEXAS, CALLING A RUNOFF ELECTION ON TUESDAY, DECEMBER 8, 2020, FOR THE PURPOSE OF ELECTING COUNCIL MEMBER PLACE 4; PROVIDING FOR EARLY VOTING AND FOR NOTICE OF THE ELECTION; AND PROVIDING FOR OTHER MATTERS RELATING TO THE ELECTION.

WHEREAS, the City of Celina is a home rule municipality located in Collin County and Denton County, Texas created in accordance with the provisions of the Texas Local Government Code, the Texas Constitution and operating pursuant to the enabling legislation of the state of Texas; and

WHEREAS, the City Council of the City of Celina, Texas is empowered under Local Government Code 54.001 to do all acts and make all regulations which may be necessary or expedient for the promotion of the public health, safety and general welfare; and

WHEREAS, under State law, if a candidate does not receive enough votes to be elected in an election requiring a majority vote, a runoff election is required for the candidates who receive the highest and second highest number of votes (Texas Election Code §§ 2.021; 2.023); and,

WHEREAS, not later than the fifth day after the date the final canvass of the main election is completed, the city council must order the runoff election (Texas Election Code § 2.024); and,

WHEREAS, the runoff election must be held not earlier than the 20th or later than the 45th day after the date the final canvass of the main election is completed (Texas Election Code § 2.025); and,

WHEREAS, the Mayor has certified to the City Secretary that the Council Place 4 candidates Wendie Wigginton and Ben Hangartner be placed on the ballot for the runoff election (Texas Election Code § 2.027).

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CELINA, TEXAS:

SECTION 1

The above and foregoing premises are true and correct and are incorporated herein and made a part hereof for all purposes.

SECTION 2

In accordance with the Constitution and general laws of the State of Texas, a Municipal Runoff Election is hereby called and ordered for Tuesday, December 8, 2020, at which election all qualified voters of the City may vote for the purpose of electing the following official of the City:

Council Member, Place 4

SECTION 3

The polling place for the voting precincts in the City of Celina for the Municipal Runoff Election Day voting is Collin County - Celina ISD Administration Building, 205 S. Colorado, Celina, Texas, and Denton County - Aubrey City Hall, 107 S. Main St., Aubrey, Texas, and Pilot Point Senior Center, 310 S. Washington St., Pilot Point, Texas.

SECTION 4

The Elections Administrator of Collin and Denton County, Texas, shall act as Contracting Officer (the "Contracting Officer") and shall appoint election judges, alternate judges and clerks as described in the Contract for Election Services between Collin and Denton Counties and the City of Celina, Texas.

SECTION 5

The Elections Administrator of Collin and Denton County, Texas, shall receive applications by mail for a ballot to be voted by mail, until the close of business Friday, November 27, 2020. Requests for applications should be mailed to:

Denton County Voters: Denton County Elections, 701 Kimberly Dr., Denton, Texas.

Collin County Voters: Collin County Elections, 2010 Rosebud Blvd., #102, McKinney, Texas.

SECTION 6

The dates and times for early voting by personal appearance shall be as follows at the location below:

SECTION 7

Such election shall be held in accordance with the Texas Election Code and only resident, qualified voters of the City shall be eligible to vote.

SECTION 8

Notice of the election shall be given as provided by law.

SECTION 9

Voting at the election, including early voting, shall be by use of the County electronic voting system that has been duly approved by the Secretary of State.

SECTION 10

That pursuant to the provisions of Chapter 87 of the Texas Election Code, an Early Voting Ballot Board is created, which Board shall consist of a presiding judge and clerks as appointed by the Contracting Officer. The Early Voting Ballot Board shall perform such functions and shall have such duties as are provided for by the Texas Election Code. In addition, the counting station for all ballots cast in such election shall be operated by the Contracting Officer, and such clerks as shall be necessary to count the ballots and to prepare the election returns in accordance with the provisions of Chapter 65 of the Texas Election Code.
