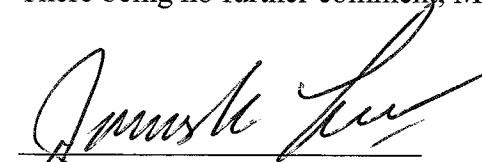
- A. The Celina City Council will conduct a public hearing to consider testimony regarding the annexation of:
- 1) 2.22 Acres located at 729 N. Louisiana (D & L Farm & Home)
 - 2) 4.42 acres located at 870 N. Preston Road (Texas Seasons Nursery & Landscape)
 - 3) 1.45 acres located at 881 N. Louisiana (FlexKrete Technologies)
 - 4) 765.3 acres (Area 2 as depicted on attached map) located across the Collin County/Denton County line and north of FM 428.
 - 5) 1368.5 acres (Area 3 as depicted on attached map) located along and east of the Collin County/Denton County line and north of FM 428 and south of Grayson County line.
 - 6) 152.2 acres (Area 4 as depicted on attached map) located along and east of the Collin County/Denton County line and south of Grayson County line.
 - 7) 92.6 acres (Area 1 as depicted on attached map) located in Denton County west of Celina Road
 - 8) 36.4 acres (Area 5 as depicted on attached map) located in Denton County south of Carey Road and west of County Road 6.
 - 9) 25.0 acres in Denton County located south of FM 428 and east of Smiley Road
 - 10) 57.18 acres in Denton County located north of FM 428 and east of Smiley Road
 - 11) 36.78 acres in Denton County located north of FM 428 and east of Smiley Road
 - 12) 104.27 acres in Collin County located north of County Road 8 and east of County Road 6
 - 13) 49.31 acres in Denton County located south of Carey Road and west of County Line Road
 - 14) 1.46 acres in Collin County located West of SH 289 and north of County Road 55
 - 15) 71 acres in Collin County located east of SH 289 and south of County Road 83
 - 16) 5.37 acres in Collin County located west of SH 289 and north of Founders Lane
 - 17) 39.53 acres in Collin County located west of County Road 50 and south of County Road 51
 - 18) 103.61 acres in Collin County located east of County Road 50 and south of County Road 51

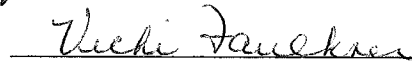
- 19) 168.78 acres in Collin County located east of the Dallas North Tollway and south of CR 51
- 20) 82.5 acres in Collin County located west of W. FM 455 and north of CR 57
