Board Member Jill Parsons made a motion to appoint Board Member Brian Bender as Vice Chair of the Arts and Culture Board. The motion was seconded by Board Member Barbara Ivey. The Board voted four (4) in favor, none (0) opposed, and two (2) abstained. The motion to appoint Board Member Brian Bender as Vice Chair carried 4-2.
