MINUTES

WORKSESSION/REGULAR SESSION 5:00 P.M.

I. CALL TO ORDER AND ANNOUNCE A QUORUM PRESENT:

Mayor Jim Lewis called the meeting to order at 5:00 p.m. Council members present were Mayor Pro Tem Dewey Isham, Bill Webber, Sean Terry and Larry Berg. Councilwoman Carmen Roberts arrived at 5:21 p.m. Councilman Wayne Nabors was absent.

II. WORKSESSION/COMMITTEE REPORTS/STAFF REPORTS:

- A. Introduction of new police officer-Paul Jones introduced Patrolman Danny Jones
- B. Fire Department Retiree Recognition-Mark Metdker recognized Billy Pell and Jack Reeves
- C. Fire Sprinkler Ordinance Review-Mark Metdker gave brief history of decision to pass the ordinance. Buddy Minett from the audience suggested that the council consider this issue a personal rights situation, consider costs, consider too many requirements and giving developers options.
- D. Quarterly Financial Report-Jay Toutouchian presented the report
- E. Parks Presentation-Flag Installation-Cody Webb related how the MIA flag came to be flown at the Southern Kitchen restaurant, citizen input and gave thanks to Wes Weston for donating the flag. City Manager Mike Foreman echoed the thanks to Mr. Weston.

VI. OPEN FORUM:

Citizen Todd McCally, 1308 Lakeview-questioned how the Fire Sprinkler Ordinance might save taxpayers money. Chief Metdker explained that a neighborhood with “sprinklered” homes could have a fire station with a different manning strategy, such as less and/or different equipment and less manpower.

- C. Consider and act upon an Interlocal Agreement with Collin County approving the transfer of funds from Collin County Project 07-00-17 (CR 5) to the city for completion of a water utility relocation at Station 465 of the TXDOT Project CSJ 0091-04-055. Johnson

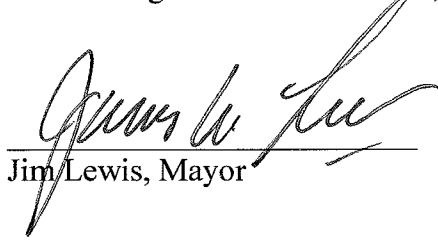
Councilman Terry moved to approve item C. Councilman Webber seconded. Motion carried. 5-yes;0-no.

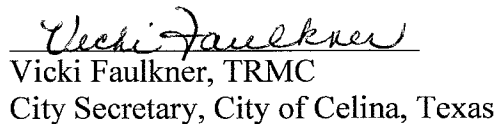
- D. Consider and act upon appointment to various City Boards/Commissions and Economic Development Board.
