I. PUBLIC HEARING:

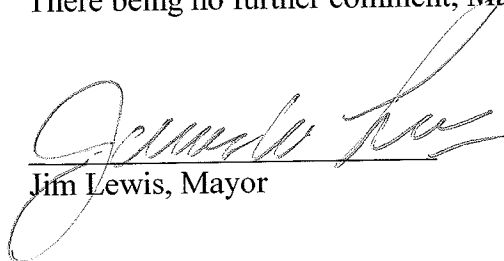

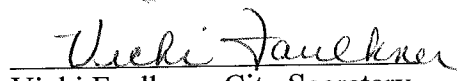

No public comment received.

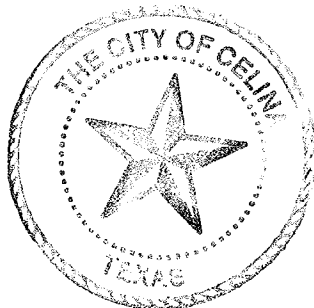
II. ADJOURNMENT:

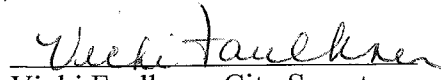
